Who we are

Daughters of Charity of St. Vincent de Paul is an international community of Catholic women founded in Paris, France in 1633 by St. Vincent de Paul and St. Louise de Marillac. The DC community exists to serve and assist people who are poor and marginalized.

Our office of the Daughters of Charity is International Project Services (DC IPS), established in 2004 as a 501 (c) (3) to help provide resources for the sisters in low-resourced countries. IPS facilitates international funding and develops relationships that support Daughters of Charity projects at the local level.

What we do



Sisters seek funding through DC IPS to support their projects
Projects address issues of hunger, poverty, neglect, health care, education, water access, human trafficking, technical training, entrepreneurship, etc.



Local Sisters work in their communities to identify needs
Sisters indigenous to the area identify needs and develop projects to assist those in need and build their vision of a thriving community



DC IPS seeks funds through foundations, donors, and gifts
DC IPS assumes the burden of seeking funds allowing Sisters to focus on helping those in need



Funds are sent to local Sisters who complete the work
100% of every donation and funds raised are assigned to the local sisters' ministries



Report is generated and sent to DC IPS
12 months after the project receives funding, Sisters generate a report outlining spending, outcomes, impact, and photos. These reports are sent to donors and foundations.
